Title of Document: 1.1 LOPR_Source of Authority

Background:

The authority of the City of Lake Oswego and of the Parks & Recreation Department (LOPR) are enabled by State Statute, City Code and Charter, and City Council Adopted Parks Rules. LOPR is guided by the previously mentioned sources of authority as well as goals and actions identified in Statewide Goals, the City Comprehensive Plan, ParksPlan 2025, the LOPR Strategic Profile, and both the LOPR Recreation and Parks Strategic Plans.
