"LOVE MY CITY" VIDEO CONTEST

The City of Lake Oswego has launched a new contest – the Love My City Video Contest! You're invited to share a video showcasing what you love about Lake Oswego for the chance to win a \$1,000 gift card. Second and third place winners will also receive gift cards - \$500 and \$100, respectively. The Love My City Video Contest is free to enter and open to professional and amateur filmmakers of all ages.

The winning videos will be presented at a Lake Oswego Council Meeting, displayed on the City's website, screened at various City events and locations throughout the year, and shared on social media.

OFFICIAL RULES AND GUIDELINES

- All entries must be received by 5:00 p.m., Friday, December 16, 2016.
- Contestants do not have to live in Lake Oswego.
- Videos must be filmed in Lake Oswego and must have been taken within two years before the entry deadline.
- Videos must be between 2-4 minutes in length, including titles and credits.
- Videos must be submitted in a common format, for example: .mp4, .mpg, .wmv.
- Contestants may submit multiple videos, but only one prize is given per contestant.
- A completed and signed Entry Agreement must accompany each video submitted. (Entry Agreements by youth under 18 years of age must be signed by parent or guardian.)
- Videos will not be returned and may be displayed on the City's website, shared through social media, shown at various City locations, and also be used for publicity and promotional purposes.
- The City of Lake Oswego, reserves the right, in its sole discretion, to disqualify any entry that it believes violates any of the rules for this contest or is otherwise not consistent with the spirit and theme of the contest.
- The City of Lake Oswego reserves the right to cancel, suspend and/or modify the contest, or any part of it, without notice.

HOW TO ENTER YOUR VIDEO

Video entries can be submitted online, by mail or in-person. A completed Entry Agreement must be submitted for each video by the deadline. Signed Entry Agreements submitted as PDF files are acceptable; we cannot accept an unsigned Entry Agreement.

JUDGING

A panel consisting of City of Lake Oswego staff and a City Councilor ("Judges") will evaluate all eligible entries based on overall quality, creativity and how well the video portrays the contest theme. The Judges will select a first, second and third place winner. The City will notify the winners by mid-January. Winners will be notified by phone or email. Only one prize is given per contestant. Decisions of the Judges are final and binding.

ENTRY AGREEMENT - LAKE OSWEGO VIDEO CONTEST

- I am the author of, and have lawful ownership rights to the video, including the publication and republication rights of the video.
- I will be responsible for all taxes, fees, and costs associated with prize receipt and/or use.
- The video is the result of Contestant's sole artistic effort.
- The video is unique and original and does not infringe upon any copyright, trademark, or patent.
- Any models or persons identifiable in the video have given approval for publication and distribution (releases) of the video as stated in this Entry Agreement, and that City shall have no obligation to compensate the models or persons.
- The video is free and clear of any lien.
- Contestant licenses to the City perpetually all rights of display, transmission, reproduction, and distribution of the video work, and to display two- or three-dimensional reproductions of any images within the video in any manner, collectively "the Work," provided however that the City's use of the Work shall be restricted to use, publication, republication, and distribution of whatsoever kind relating to any City publication or event, including, without limitation, public display as well as reproduction on City items, such as movie, television, internet (electronic display and distribution), print ads, postcards, posters, brochures, applications, City website, and any other of distribution or display, whether print, electronic, or televised. In addition, the City may alter or convert the images of the Work as necessary to fit into a reduced or enlarged format size, or a different format. The photo may be reproduced, displayed, or distributed in any form without credit to the Contestant. The Contestant retains ownership and copyright, including the right to similarly display, transmit, reproduce, and distribute the Work. No compensation shall be due to Contestant.
- Contestant agrees to release, defend, indemnify and hold harmless the City, its agents, officials, employees, and volunteers from and against any and all claims and liability, including but not limited to copyright, trademark, or patent infringement, arising out of Contestant's participation or association with the City of Lake Oswego Video Contest, or screening or distribution of the video. Contestant agrees to pay all costs incident to any claim, including, without limitation, attorneys' fees.
